

And Whereas the Trustees in their meeting held on 01.11.2019 passed a Resolution to add the Dissolution clause in Trust deed as under:-

Dissolution of the trust – If the Trust is to be dissolved or wound up for reason that the objects of the Trust cannot be achieved or for any other reason thought fit by Trustees then, The Trustees in their meeting under Chairmanship of Managing trustee may take the decision to dissolve the trust by the majority of 75% vote. However in passing the resolution Chairman shall have the veto power, i.e. He may cancel the resolution of dissolution in same meeting and not later on.

In the event of dissolution or wind up of the Trust, the assets remaining as on the date of dissolution shall under no circumstance be distributed among the existing Trustees but the same assets of the trust, shall be after clearing / paying all its liabilities or along with its liabilities as may be decided by the trustees; transfer its assets to the similar object and / or Nature trust, society or section & company incorporation under the companies Act, 2013 or companies Act 1956, or Trustees may transfer the reaming assets of Trust to more than one Trust, society or section & company incorporation under the companies Act, 2013 or companies Act 1956. And the transferee Trust, institute/Trust/Society/company will enjoy full right over the assets. Transferor Trust or trustees will not have any right of interference on the assets as a Trustee of this Trust.
